AMA Will Undertake Smoking-Health Study

_{øbor} Unions Plan Anti-Smoking Drive

A spokesman for the American Fedation of Labor and Congress of Instrial Organizations told a staff conrance of the American Cancer Society New York last week that organized bor would open a drive among its embers in January against excessive mking.

The drive will be part of a nationde campaign of cancer education and promote early detection of the sease, Leo Perlis, national director of federation's Community Service divities said. He spoke at the society's eting at the Biltmore Hotel.

Mr. Perlis said the drive would be mied on in spite of the fact that union embers make the cigarettes, cigars d tobacco and pipes used in smoking. PORTLAND, ORE. – A long-range study to determine the effect that smoking has on the human body was ordered here last week by the House of Delegates of the American Medical Association.

In presenting the proposal to AMA's board of trustees the policy-making group, said:

"So many gaps exist in knowledge about the relationship of smoking to health it is the belief of the board that an intensive long-range research program, such as is proposed, is imperative."

The project would be initiated by the Education and Research Foundation of the AMA, a separate corporate entity from the association itself.

The board recommended that the long-range program be financed by a substantial contribution from the AMA and solicitations from other sources, such as industry, foundations, voluntary health agencies and private physicians. It emphasized, however, that no restrictions would be permitted with contributions.

The proposed research program would be conducted in three phases, according to the board. The first would entail a continuing survey of the literature on the subject.

Next, there would be research on tobacco and disease, and, finally, coordinating research would be carried out by others.

The AMA itself would utilize various avenues in communicating the results of the research studies as they become available.

"A director for this project will be procured whose experience, qualifications and integrity will assure that such a research project will be conducted effectively, exhaustively and with complete objectivity," the board said.

"A mass of statistical information," it said, "has been developed indicating certain relationships between smoking and disease which cannot be ignored, even though the significance of them in terms of cause and effect is still being debated."

The proposal explained that the research program would be designed to go beyond statistical evidence and to

Senator Neuberger Sees AMA Aiding Tobacco Trade

WASHINGTON, D. C. – Senator aurine B. Neuberger (D.-Ore.) in reirks prepared for delivery to the mate last week, charged that action ien by the AMA House of Delegates tember 4 in calling for "long-range" warch into the health effects of oking, without taking a position on e evidence, "could not have been ther designed to achieve the objectives the American tobacco industry."

The American Medical Association tion followed delivery of a massive port by Dr. E. Cuyler Hammond, of American Cancer Society, confirmand reinforcing previous evidence at cigarette smoking causes premature ortality among cigarette smokers.

Isn't it a little late for the AMA to us to start at the beginning. Of use we need additional research, but at we need more, and **now**, is un-^{Uvocal} warning to every American. ^{A smoking}, by whatever mechanism ^{a serious} threat to health."

Mrs. Neuberger questioned the Inre of the AMA to acknowledge the Incer Society report or to await the pending report of the Surgeon General's Advisory Committee on Smoking and Health. She noted that on March 12. 1963, a spokesman for the AMA had stated that the Association would "make a statement based on a critical evaluation" of the Surgeon General's report. Yet yesterday's statement of the AMA's Board of Trustees made no mention of the Surgeon General's report nor of any future plans by the AMA to adopt an official position on smoking and health.

As evidence that the AMA action played into the hands of the tobacco industry, which has long maintained that there is insufficient evidence of the harmful effects of smoking to justify action, Senator Neuberger quoted remarks by two tobacco spokesmen on the AMA decision.

"George V. Allen, president of the Tobacco Institute said:

'It is interesting to note that following Dr. Hammond's report the AMA today approved a program for the AMA's education and research foundation to undertake an extensive, long-range research program on smoking and health . . . designed to probe beyond the statistical evidence. 'We welcome any program for further scientific research in these important health fields, where so many questions remain unresolved.'

"And Dr. Clarence Cook Little, chairman of the Tobacco Industry Research Committee chimed in: 'We are gratified by the reports of the AMA's recognition of the need for addiitonal research on smoking and health.'

Mrs. Neuberger concluded:

" I do not know why the AMA has taken this action in this way, at this time. But I do know that it could not have been better designed to achieve the objectives of the American tobacco industry. So long as the industry succeeds in convincing the American public that the verdict on smoking is not in, that there are great 'gaps' of knowledge remaining, that the evidence is still subject to 'debate,' the vast majority of habitual smokers will be able to rationalize their habit, comforting themselves in the erroneous belief that the case against the cigarette remains 'unproved'.

"This tacit recommendation by doctors for the continuation of smoking, is a disservice to the American people."

earch for answers to such questions s which diseases are either caused or aduced by smoking.

It stated that a determination should made to find what elements, if any, may be a direct aggravating cause of ancer and other diseases and to identify hese substances chemically.

It also recommended that answers be ought on psychological factors and abituation connected with smoking -VIT.

Dr. Clarence Cook Little, scientific lifector of the Tobacco Industry Reearch Committee, issued the following, tatement in New York following reuests for comment on a decision by the American Medical Association to aunch a research program on tobacco and health:

"We are gratified by reports of the merican Medical Association's recogition of the need for additional reearch on smoking and health.

"The beginning of such a major reearch program by the AMA's Education and Research Foundation should reed the day when science will learn be causes of major health problems, whas lung cancer and heart disease, ad what role, if any, smoking may ave.

The AMA, referring to 'large gaps knowledge,' cites the need for rearch 'beyond statistical evidence.' It wis it plans research on smoke itself. constitutional, physiological and wchological factors, clinical and pathingical studies, as well as studies on mether 'smoking may produce a tranmether 'smoking may produce a tranmether favorble psychic reactions. . . .'

The TIRC itself last week anunced the appropriation of an addiadd and \$1 million for continuing and exanded research during 1964, and Reed to provide any additional funds quested by the Scientific Advisory Board to the TIRC," Dr. Little said.

WASHINGTON, D.C. – Asked for comment on a report by Dr. E. Cuyler Hammond of the American Cancer Society at an American Medical Association meeting recently, George V. Allen, president of The Tobacco Institute, Inc., issued the following statement:

"I feel certain that Dr. Hammond's additional statistical studies reported to the American Medical Association today will receive careful consideration from scientists working in the field.

"It is interesting to note that following Dr. Hammond's report, the AMA today approved a program for the AMA's Education and Research Foundation to undertake 'an intensive, longrange research program (on smoking and health) . . . designed to probe beyond statistical evidence, to search for answers not now available to such questions as which diseases in man may be caused or induced by the use of tobacco'.

"We welcome any program for further scientific research in these important health fields, where so many questions remained unresolved. We are gratified that the work is to be undertaken by so widely representative a body as the AMA."
