#### DOC Stirs National Interest

As DOC continues its campaign to promote healthier lifestyles, it is beginning to command the attention of organizations ranging from the AMA to the U.S. Army. An article in a recent issue of JAMA notes DOC's efforts to educate the public about disease prevention through mass media campaigns (See "Medical News" JAMA, Dec. 28, 1979). In addition to the DOC school programs, bus-stop bench and radio adverisements, the article refers to the idea expressed by Alan Blum, MD that physicians can be "prevention specialists". DOC co-founder Blum is cited for suggesting that physicians learn to talk with patients about the dangers of smoking in a personalized, well informed manner. Also noted is his suggestion that doctors display in their offices only those magazines that do not accept cigaret advertising. According to the article, DOC's public education tactics can be extremely effective. It says, "Available evidence indicates that these stategies can have a major impact if a substantial number of physicians take part."

Blum has also had an article published in JAMA (See "Medicine Verses Madison Avenue" JAMA, Feb. 22/29, 1980). In this analysis of the relationship between advertising and health habits, good and bad, Blum cites the DOC program as one way to combat poor health habits which are often promoted in mass media advertising.

DOC has also attracted the attention of the U.S. Army. The DOC program has been enthusiastically endorsed by medical officers at the Dwight David Eisenhower Army Medical Center, Fort Gordon, Georgia. An entire issue of The Examiner, the medical center's newpaper, was devoted to cancer and its prevention. Lung cancer and its causes, namely smoking, received considerable attention. Six of eight writers contributing to the special issue were DOC members.

Fort Gordon DOC members also launched a Cancer Awareness week. Hour-long programs about cancer were presented twice daily to the fort's personel. The efforts of the Fort Gordon DOC members attracted the attention of the Augusta, Ga. press. Both the Augusta Herald and Augusta Chronicle contained interviews with DOC members Rick Richards and Captain Gregory Blake.
