AS THE AMERICAN MEDICAL ASSOCIATION MEMBER WHO INITIATED THE

THE MEMBERS' RETIREMENT FUND, I WAS PLEASED TO LEARN THIS WEEK THAT  
THE AMA HAS AT LONG LAST DISPOSED OF ITS \$1.4 MILLION HOLDINGS IN  
R.J. REYNOLDS AND PHILIP MORRIS.

ALTHOUGH I HAVE WATCHED WALL STREET WEEK IN REVIEW FOR SEVERAL YEARS,  
I DO NOT RECALL YOUR HAVING DEVOTED AN ENTIRE PROGRAM TO A TOPIC THAT  
HAS BEEN EITHER EUPHEMISTICALLY OR CYNICALLY LABELED "SOCIAL  
INVESTING". ON THE OTHER HAND, YOU HAVE FEATURED AT LEAST ONE TOBACCO  
ANALYST WHO GLOWINGLY RECOMMENDED THE PURCHASE OF CIGARETTE STOCKS.

IT SHOULD BE POINTED OUT THAT NOT ALL OF US WOULD-BE "SOCIAL  
INVESTORS" ARE ACTING ON THE BASIS OF SOME ARBITRARY PERSONAL  
MORALITY OR ANTI-CORPORATE BIAS. HOWEVER, NOW THAT THE AMA HAS  
GRASPED THE IMPROPRIETY OF PROFITING FROM THE SALE OF THE SINGLE MOST  
PREVENTABLE CAUSE OF DEATH, DISEASE, AND HIGH MEDICAL COSTS IN OUR  
SOCIETY, THE QUESTION I HOPE YOU WILL HAVE THE COURAGE TO ADDRESS ON
