Thanks, Anthony. This is such a great idea that I now must insist we increase the budget so that we can tell the story of the KENT Micronite filter as a mini-exhibit within the overall exhibition. Surely all of the things you describe in your note, not to mention your time, would be worth far more. I think I should include my intact, unopened asbestos-era KENT pack to the mix, too.

The overall exhibition is entitled, "Cartoonists take up smoking," and it tells the story of the tobacco controversies over the latter half of the 20th century, as seen through the eyes of the nation's newspaper editorial cartoonists. More than 80 original cartoon artworks are in the exhibition (which will open at the National Museum of Health and Medicine next year), in addition to approximately 120 supplemental items (such as a copy of the original 1964 report of the Surgeon General, original newspapers with smoking related headlines, and a large number of advertisements and promotional materials). Although I don't know of any editorial cartoons about the micronite filter or about smoking and asbestos, it's possible I can come up with an angle that could justify including the KENT display.

I'd like to mention this idea to the director of the Museum, as we head into the final planning stages. (Early versions of the exhibition have been shown in Lexington (Kentucky), Seattle, Birmingham, and Tuscaloosa.)

Thank you for your kind words regarding the Kent Micronite display. And, thank you for sharing some of your incredible recollections about the asbestos Kent Micronite filter; astounding details indeed.

It would be my pleasure to work with you in providing Kent Micronite Filter display items for your exhibit (and within your indicated budget). Along this line, I also have a couple of ideas for showcasing the filter materials in the display, per your approval.

In addition to my eBay hobby endeavors, I construct asbestos material displays for environmental training providers in my area. The display containers are larger than the single-cigarette display, and consequently, hold more materials. These larger acrylic display cases are also completely clear, durable, and sealed. The mounted sample pieces are secured firmly in place and are quite visible; the training providers seem to find them indispensable.

I was thinking of making a display that includes: a nicely presented "intact" Kent Micronite Filter cigarette; a dissected

Micronite filter enclosed within a clear petri dish; a "cabinet" size mineral specimen of crocidolite; and a small, sealed vial of separated blue-grey crocidolite fibers; and photos with magnified images of the crocidolite/fibrous filter materials. All items would be appropriately labeled, highlighting each of their respective relevant features.

The cigarette by itself is astonishing in its own right; but I also believe that including a cut apart filter showing the bluish crocidolite asbestos and including an exemplary mineral sample of actual crocidolite along with the display would seem to connect the filter's bewildering "asbestos/tobacco" relationship even more. It's just a marvelous historical moment. The modern angle is that no filte ( with or without asbestes, confere any health benefit, and that's the ultimate point. We should say that today nearly all cigarettes are filtered brands, in spite of the fact that the filter does not make smoking in any way, shape, or form safer. In fact, by having to suck harder to get the smoke, this increases the risk for emphysema and heart disease by increasing the exposure to poison gases like carbon monoxide, cyanide, and ammonia. I could see the overall headline: "The Filter as Fraud." They'd never let that get used, so perfahps we should simply say "The Filter: Not Safer." The filter is made of cellulose acetate rolled like a little roll of toilet paper. There are holes in the filter to ventilate the smoke, but since our lips cover these holes, they only serve to fool the machines that measure, at the tip, the levels of poisons in each cigarette. Lori,

I could possibly duplicate the display materials that were sent in your last package, but it would require dissecting an extra Micronite Filter cigarette this next time.

In a brief mention in earlier correspondence with Dr. Blum, I had indicated the suggestion that I could include the "dissected" Kent Micronite Filter cigarette along with the "intact" Kent Micronite Filter display which he was initially interested with on eBay. The "dissected"

cigarette materials originally came from an "experiment" for photo-documentation purposes for the original eBay auction description (refer to the eBay auction description documents; see photo depicting tweezers with Crocidolite asbestos bundle from dissected filter textile matt). Thus, the "dissected" cigarette that was sent to you was the "experimental dissection" and was already available. I had suggested it might add an increased level of interest to the overall Kent Micronite Filter display concept and the "extra" material was readily prepared.

My current available supply of intact original Kent Micronite Filter cigarettes are somewhat limited. However, if you believe it is in the best interest of your exhibition/showcase purposes, I can dissect and prepare an extra Kent Micronite Filter cigarette and include it with the other basic Kent Micronite display materials (like the display package sent to you recently).

The "other suggested display components" for the Micronite display series that are available, basically consist of:

- --The original 1955 King Size Kent Micronite cigarette package; empty, but in very good condition. In such good condition in fact, that when it was opened, it was carefully opened from the bottom leaving the original cellophane wrapping almost entirely intact. The original 1"-wide, blue, Series #125 DeWitt-Clinton tax stamp is perfectly intact on the top of the package and appears in its sealed/undisturbed condition. The empty package has not been crushed nor pressed, but rather, it appears to maintain its "full" shape. A historical item to display alongside the Kent Micronite cigarette materials.
- --Various sizes of display cases. I included the larger clear acrylic display case with the reflective base in your last package, which seemed to adequately accommodate all of the individual pieces. However, there are smaller cases with similar design features (i.e.- reflective base, shape, etc.) that can be customized to suit your specific display configuration if needed.

These do NOT contain asbestos, but do offer a historical comparison between filter types from an early era of filter-tipped cigarettes, particularly between original Micronite Filter cigarettes. The filter media of these cigarettes appear to be slightly "off-color" (very light grey-ish blue), consistent with the reported dye-effect attempts by Lorillard to "brand" or distinguish the Micronite filter.

Lori,

I could possibly duplicate the display materials that were sent in your last package, but it would require dissecting an extra Micronite Filter cigarette this next time.

In a brief mention in earlier correspondence with Dr. Blum, I had indicated the suggestion that I could include the "dissected" Kent Micronite Filter cigarette along with the "intact" Kent Micronite Filter display which he was initially interested with on eBay. The "dissected"

cigarette materials originally came from an "experiment" for photo-documentation purposes for the original eBay auction description (refer to the eBay auction description documents; see photo depicting tweezers with Crocidolite asbestos bundle from dissected filter textile matt). Thus, the "dissected" cigarette that was sent to you was the "experimental dissection" and was already available. I had suggested it might add an increased level of interest to the overall Kent Micronite Filter display concept and the "extra" material was readily prepared.

My current available supply of intact original Kent Micronite Filter cigarettes are somewhat limited. However, if you believe it is in the best interest of your exhibition/showcase purposes, I can dissect and prepare an extra Kent Micronite Filter cigarette and include it with the other basic Kent Micronite display materials (like the display package sent to you recently).

The "other suggested display components" for the Micronite display series that are available, basically consist of:

- --The original 1955 King Size Kent Micronite cigarette package; empty, but in very good condition. In such good condition in fact, that when it was opened, it was carefully opened from the bottom leaving the original cellophane wrapping almost entirely intact. The original 1"-wide, blue, Series #125 DeWitt-Clinton tax stamp is perfectly intact on the top of the package and appears in its sealed/undisturbed condition. The empty package has not been crushed nor pressed, but rather, it appears to maintain its "full" shape. A historical item to display alongside the Kent Micronite cigarette materials.
- --Various sizes of display cases. I included the larger clear acrylic display case with the reflective base in your last package, which seemed to adequately accommodate all of the individual pieces. However, there are smaller cases with similar design features (i.e.- reflective base, shape, etc.) that can be customized to suit your specific display configuration if needed.
- --Various sizes and grades of Crocidolite mineral samples; larger/smaller, with/without matrix rock, "processed", variable colorations, mounted/unmounted specimens, etc.
- --An unopened pack of 1952 Kent Micronite Filter cigarettes (1"-wide, blue DeWitt-Cinton tax stamp) Series # 122; in very good condition. The cellophane is absent from this regular-sized pack, but the package is in great shape. The seal is perfectly intact and undisturbed. 1952 is the first year of production of the Crocidolite-asbestos Kent Micronite Filter Cigarettes. This asbestos/tobacco artifact has been well protected.
- --An unopened pack of 1953 Kent Micronite Filter cigarettes (1"-wide, blue DeWitt-Clinton tax stamp) Series #

123; in very good condition. The original cellophane is perfectly intact, as well as, the seal of this regular-sized pack. A nicely protected example of this second-year production Kent Micronite cigarette pack.

--1955 King Size or 1953 Regular Size Kent Micronite Cigarettes.

Mounted, labeled, and displayed; or, available separately in unprepared condition. The condition of these individual asbestos-containing cigarettes range from fair to very good.

-- Also available, are 1959 King Size Kent Micronite Filter Cigarettes.

These do NOT contain asbestos, but do offer a historical comparison between filter types from an early era of filter-tipped cigarettes, particularly between original Micronite Filter cigarettes. The filter media of these cigarettes appear to be slightly "off-color" (very light grey-ish blue), consistent with the reported dye-effect attempts by Lorillard to "brand" or distinguish the Micronite filter.

Lori, thanks again for the opportunity to provide Kent Micronite/asbestos-related display materials for your exhibition/showcase purposes. Just let me know what pieces and configuration you might be interested with that accommodate your budget and an anticipated schedule/date you'd like to receive them.
