I was appalled to discover that Western Michigan University recently presented the Employer of the Year Award to the Philip Morris Co. That the university would even consider rewarding a company whose products are responsible for so many deaths makes me shudder.

This year alone, Michigan deaths directly attributable to tobacco are approximately 16,000. Philip Morris' market share of tobacco sales is 50 percent, meaning that Philip Morris products are responsible for about 8,000 of these deaths.

Last week Philip Morris products killed 135 Michiganders by giving them horrible diseases -- heart disease, lung disease, cancer and emphysema.

That same week, Philip Morris spent \$4 million in Michigan promoting cigarettes and smoking, making it look sexy, fun and cool.

It seems odd, and absurdly and shamefully inappropriate, that this should warrant an award. What kind of a message is this sending -- that it's OK to kill people as long as the company is providing jobs?
